
## **Kinney Shores Association | Meeting Minutes**

Rick Campbell introduced and called up Kevin Sutherland, city administrator to speak to the group to discuss issues surrounding Camp Ellis and the recent proposal for zoning changes in Saco.

Relative to the zoning proposal (attached & on the kinneyshores.com website), Kevin mentioned that this has stemmed from interest from KS residence to split up larger lots. Biggest challenge in Saco is where Rt. 112 comes into Saco via Industrial Park Road. More development in West Saco is continuing to add to significant traffic congestion. Considering an additional spur onto I95. Kevin has made the suggestion that in the downtown area to allow for less restrictive height restrictions. Don Girouard (Saco planning board) is suggesting greater 'infill' in Kinney Shores with the goal is to have 'smart growth' to offset taxes, etc.

Concerns were raised from the KSA membership regarding perceived intent to increase density in Kinney Shores, while decreasing density in the Bayview area. Kevin pointed out that the document has not been accepted and is simply a proposal. Currently this is one planning board members perspective. Membership in attendance also raised concerns regarding the timing of when this will be discussed — most are away other than the summer. A webinar and/or teleconference idea was proposed to allow for those away to participate.

Kevin mentioned that his department is currently in a state of transition: City Planner – Bob Hamlin recently retired. A Director of Panning & Development has been hired, who is now in the process of hiring 2 other sub-roles.

Pam Cardin raised concern with having someone involved who understands conservation/sea level rise concerns. Question was raised of what if the board wants to move forward with the mayor – this would lead to a public hearing, posted in paper, then it would move to a vote. Comprehensive plan for Saco – updated this February, speaks to density but solely on downtown areas and language around walkable/sustainable communities.

The presence of a KSA member at public hearings will be considered as representing the entire KS community. Clarification was requested on proposal so that membership can read bullet points of topline effects. Lynn Copeland (Councilor Ward 4, <a href="mailto:councilward4@sacomaine.org">councilward4@sacomaine.org</a>) was the one to share this document with KSA. Don Girouard drafted this document and is a member of the Saco planning board. We need to get involved – when there are opportunities to discuss, then KSA will be invited.

Camp Ellis jetty extension – report has gone to Army Core Headquarters, report has been revised over the past 2.5 years, and is now in their hands. Seems to be progressing. Next step is for federal government to approve and fund. Dredging of Saco River to take place again and placed on Camp Ellis beach. Sue Burdsall pointed out that this sand moves Northward and causes problems in KS and the creek. Page on Saco page related to Jetty.

Pam Cardin shared that there was a great presentation on sea level rise from the Gulf of Maine institute – additional event was held @ Oceanwood in July to discuss 'resiliency plans' – raising houses, etc. Fastest growing body of water – Gulf of Maine. If interested in more details, contact Pam Cardin.

**Membership Committee:** Lynn Godbout and Sue Burdsall. It was highlighted that there were 4 new households represented at the meeting – WELCOME!! - word of mouth is best way to spread the word about the Kinney Shores Association. Benefits include maintenance of the boardwalks, dog bags, additional 'drive slow' signage, and most importantly to give our community a voice when issues arise that affect our unique corner of greater Saco.
